4. The seller will not accept return of goods unless such return is authorised by the seller.
5. GST is not included in prices quoted unless so stated, but will be charged to the buyer's account when applicable.
6. The Guarantors personally guarantee full payment of any outstanding account, and any expenses incurred in obtaining or attempting to obtain payment of any overdue amount shall be recoverable as part of the overdue amount.
